

## **Memo of Understanding**

The purpose of this document is to memorialize the agreement between your church and Men in HD as it pertains to the 2024 Men in HD Conference and your commitment of participation. For us to meet our guidelines we need to have a signed memo of understanding from each church that will be attending.

Here is some key information for your decision-making process:

- We will be moving to Woodleaf Conference Center located in Challenge. This venue is located above Marysville and about 90 minutes northeast from Sacramento.
- We have signed the contact with Woodleaf for the weekend of September 20-22, 2024.
- Our keynote speaker will be Drew Sodestrom of Vintage Grace Church located in El Dorado Hills.
- Woodleaf is primarily a cabin driven housing model. Based on our contract negotiation, we can get the price down to \$229 per person. This covers 5 meals and two nights of housing.
- The 2024 payment plan is 25% of your total contract is due on signing of contract. For your MOU to be applicable both the signed MOU and 25% deposit must be received by Men In HD. The final 75% of total contract is due on September 6<sup>th</sup>, 2024.
- All beds are sold at the same price point. Each church that purchases at least one cabin, will be allotted a small amount of semi-private and/or private beds to accommodate special needs.
